(2) Any police officer or any officer authorised by the Port Director may seize and detain any merchandise in respect of which an offence against paragraph (1)(b) of this regulation is committed in his view and the court may, upon convicting any person of any such offence, order that the merchandise be forfeited or destroyed.

**11.** Any person who contravenes any provision of General penalty. these Regulations for which no other specific penalty is provided, shall be guilty of an offence and liable on summary conviction to a fine of seventy-five dollars.
