

Non-application.

- 4.** The exemptions granted by this Order shall not apply—
- to ships' and aircraft personnel;
 - to H.M. Forces and others travelling on official duty.

Interpretation.

- 5.** In this Order the expressions “authorised dealer” and “scheduled territories” have the meanings ascribed to them by subparagraph (1) of regulation 44 of the Exchange Control Regulations.

EXCHANGE CONTROL REGULATIONS (BAILEES EXEMPTION) ORDER

(REGULATION 31)

[Commencement 1st October, 1965]

Exemptions.

- 1.** There shall be exempted from the obligation imposed by the provisions of regulation 3 of the Exchange Control Regulations, any banker to the extent that he shall not be required to notify the Controller of Exchange as provided in the said regulation 3 in any case where he is satisfied that the person for whom or by whose order any gold or any specified currency in the form of notes is held is not required by virtue of the provisions of regulation 2 of the Exchange Control Regulations, to offer that gold or specified currency, or cause it to be offered, for sale to an authorised dealer.

Non-application.

- 2.** The Controller of Exchange may at any time direct that the exemption conferred by this Order shall not apply as may be specified in the direction.

EXCHANGE CONTROL REGULATIONS (LENDING TO BANKS EXEMPTION) ORDER

(REGULATION 31)

[Commencement 11th August, 1966]

Exemption.

- 1.** (1) There shall be exempted from the provisions of paragraph (3) of regulation 30 of the Exchange Control Regulations the lending of money or securities by any

person resident in The Bahamas to any office or branch in The Bahamas of a bank which is by any means controlled (whether directly or indirectly) by persons resident outside the scheduled territories.

(2) The Controller of Exchange may at any time direct that the exemption conferred by this Order shall not apply as may be specified in the direction.

**EXCHANGE CONTROL REGULATIONS
(COLLECTORS' PIECES EXEMPTION) ORDER**

G.N. 22.9/1956

(REGULATION 31)

[Commencement 1st October, 1956]

1. There shall be exempted from regulations 1, 2 and 3 of the Exchange Control Regulations any gold coin which was minted in 1816 or earlier and any gold coin which was minted after 1816 and which has a numismatic value greater than the value of the gold content which would have been received if the coin had been sold to an authorised dealer.

Exemptions.

2. The Controller of Exchange may at any time direct that the exemption conferred by this Order shall not apply as may be specified in the direction.

**EXCHANGE CONTROL REGULATIONS
(TEMPORARY VISITORS' EXEMPTION) ORDER**

G.N. 229/1956

(REGULATION 31)

[Commencement 1st October, 1956]

1. There shall be exempted from the obligations imposed by the provisions of regulation 2, of the Exchange Control Regulations, any person in The Bahamas who is not resident in The Bahamas.

Exemptions.

2. The Controller of Exchange may at any time direct that the exemption conferred by this Order shall not apply to such person as may be specified in the direction.
