**THE LOTTERIES AND GAMING ACT  
(Chapter 387)**

**THE LOTTERIES AND GAMING  
("BAHAMAS WHOLESALE AGENCIES LIMITED LONGBEACH  
JUNKANOO TICKET COMPETITION) ORDER, 2012**

**WHEREAS** by subsection (3) of section 18 of the Lotteries and Gaming Act (hereinafter referred to as the "the Act"), the Minister may, by order, authorize any person to conduct a competition on such terms as he thinks fit;

**AND WHEREAS** BAHAMAS WHOLESALE AGENCIES LIMITED has applied to the Minister to conduct a competition during the period 1<sup>st</sup> day of October, 2012, to the 15<sup>th</sup> day of December, 2012, in accordance with the official rules of that competition;

**AND WHEREAS** the Minister wishes to authorize BAHAMAS WHOLESALE AGENCIES LIMITED to conduct the aforesaid competition:

**NOW THEREFORE**, in exercise of powers conferred by subsection (3) of section 18 of the Act, the Minister makes the following Order—

**1. Citation.**

This Order may be cited as the Lotteries and Gaming ("BAHAMAS WHOLESALE AGENCIES LIMITED LONGBEACH JUNKANOO TICKET COMPETITION") Order, 2012.

**2. Authority to conduct competition.**

BAHAMAS WHOLESALE AGENCIES LIMITED during the period 1<sup>st</sup> day of October, 2012, to the 15<sup>th</sup> day of December, 2012, may conduct a competition in accordance with the official rules of that competition.
