## LOCAL GOVERNMENT ACT (CHAPTER 37)

### LOCAL GOVERNMENT (COUNCILLORS) (THIRD SCHEDULE DISTRICTS) ORDER, 2017

The Minister, in exercise of the powers conferred by section 10(4) of the Local Government Act, makes the following Order —

**1. Citation.**

This Order may be cited as the Local Government (Councillors) (Third Schedule Districts) Order, 2017.

**2. Specification of number of Councillors.**

The population of a local government district specified in the first column of the Schedule shall elect to the District Council for that district, the respective number of Councillors specified in the fourth column of the Schedule in relation to the respective constituencies and polling divisions, islands and settlements of that district, specified in the second and third columns of the Schedule.

**3. Revokes S. I. No. 107 of 2013.**

The Local Government (Councillors) (Third Schedule Districts) Order, 2013 is hereby revoked.
