Declaration of port area.


- 2. (1) The port area referred to in subparagraph (2), and shown by the area shaded purple on the Grand Bahama Port Limits and Anchorage Chart in Part 1 of the Schedule, is hereby declared Grand Bahama (No.3) (Eight Mile Rock) Port Area.
- (2) The port area is a parcel of Crown Sea Bed situate south-west of the Freeport Harbour approximately 3847 feet from the high water mark and bounding on the south-western most point of the Freeport Harbour limits with local grid coordinates of 2934281.58 Meters North. 720359.22 Meters East as a point of beginning, and extending at a bearing N 198°16'46" for a distance of 307.17 feet or thereabouts to a point; extending at a bearing N 305°53'01" for a distance of 6061.94 feet or thereabouts to a point; extending at a bearing N 6°10'13" for a distance of 854.69 feet or thereabouts to a point; extending at a bearing N 124°36'52" for a distance of 6035.54 feet or thereabouts to a point; extending at a bearing N 184°17'48" for a distance of 684.57 feet or thereabouts to the point of beginning; and described by the WGS84 coordinates set out in Part 2 of the Schedule.
