
ROYAL BAHAMAS POLICE FORCE BAND (FEES FOR PRIVATE ENGAGEMENTS) REGULATIONS

S.I. 25/1984

(SECTION 104)

[Commencement 28th June, 1984]

1. These Regulations may be cited as the Royal Bahamas Police Force Band (Fees For Private Engagements) Regulations.

Citation.

2. In these Regulations —

Interpretation.

“private engagement” means any engagement which is not of an official nature and which is organised by a private person or persons for private entertainment or profit;

“the Band” means the Royal Bahamas Police Force Band.

3. The fees for any private engagement approved by the Commissioner and rendered by the Band on the application of any person under the provisions of section 104(2) of the Police Act* shall be as set out in Part I of the Schedule to these regulations.

Fees payable for private engagement.

4. (1) Any fee payable by any person under these Regulations shall be paid to the Commissioner and shall be recorded in a register maintained for that purpose.

Apportionment of fees.

(2) The Commissioner shall pay to each member of the Band who performed at the private engagement the fee set out in Part II of the Schedule.

(3) The amount of any fee paid under regulation 3 remaining after deduction therefrom of the amount paid to the members of the Band shall be paid by the Commissioner into a fund for the purchase of equipment and maintenance of the Band’s instruments.

**POLICE (FEES FOR SPECIAL SERVICES)
(AMENDMENT) REGULATIONS**

S.I. 26/1984

(SECTION 104(2))

[Commencement 28th June, 1984]

Citation.

1. These Regulations which amend the Police (Fees For Special Services) Regulations, may be cited as the Police (Fees For Special Services) (Amendment) Regulations, 1984.

Amends S.I. No.
181 of 1965.

2. The principal Regulations are amended in the following respects —

- (a) in paragraph (1) of regulation 3 —
 - (i) by deleting the words, “a sum equal to two-thirds of the fee so paid”;
 - (ii) by inserting after the word “pay” the words “such fee”;
- (b) by deleting paragraph (2) of regulation 3;
- (c) by deleting the Schedule and substituting the following therefor —
