**1.** This Order may be cited as the Revised Edition of the Laws (Omitted Subsidiary Legislation) Order, 2003.

**2.** In this Order, “revised edition” means the 2000 Revised Edition of the Subsidiary Legislation updated to April 2, 2002 and prepared under the provisions of the Law Reform and Revision Act.

**3.** It is hereby declared that the enactments specified in the Schedule have been omitted from the revised edition and that these enactments continue in force.
