Speed limit.

- 8. (1) Save hereinafter specified the speed limit for motor vehicles throughout the Island of Long Island shall be forty miles per hour for motor vehicles other than omnibuses having a seating capacity for more than twenty passengers or motor trucks for which the speed limit shall be thirty miles per hour.
- (2) The speed limit for all motor vehicles shall be twenty miles per hour within the limits of settlements in the aforesaid Island or along such lengths or parts of any road where it is so indicated by traffic signs.

Use of vehicles in emergency.

9. The provisions of regulation 8 of these Regulations shall not apply to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes if the observance of these provisions would be likely to hinder the use of such vehicle for the purpose for which it is being used on that occasion.

1. These Regulations may be cited as the Road Traffic and Speed Limit (Fresh Creek, Andros) Regulations.

Speed limit.

- 2. (1) Save as hereinafter specified the speed limit for motor vehicles throughout the district of Fresh Creek, Andros, shall be forty-five miles per hour for motor vehicles other than omnibuses having a seating capacity for more than twenty passengers or motor trucks for which the speed limit shall be thirty miles per hour.
- (2) The speed limit for all motor vehicles shall be twenty miles per hour within the limits of settlements in the aforesaid district or along such lengths or parts of any road where it is so indicated by traffic signs.

Use of vehicles in emergency.

- 3. (1) The provisions of regulation 2 of these Regulations shall not apply to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes if the observance of these provisions would be likely to hinder the use of such vehicle for the purpose for which it is being used on that occasion.
- (2) The provisions of these Regulations shall be in addition to any of the provisions of the regulations made

under the Road Traffic Act which are applicable to the district of Fresh Creek, Andros.

- 1. These Regulation may be cited as the Road Traffic Short title. and Speed Limit (Abaco) Regulations.
- In these Regulations, unless the context otherwise Interpretation. requires —
 - "Controller" means the Commissioner for the District of Green Turtle Cay, Abaco, or the Commissioner for the District of Marsh Harbour, Abaco, or the Commissioner for the District of Sandy Point, Abaco:
 - "District of Green Turtle Cay" means the district of Green Turtle Cay, Abaco, as determined by the Minister under the provisions of the Local Government Act:
 - "District of Marsh Harbour" means the District of Marsh Harbour, Abaco, as determined by the Minister under the provisions of the Local Ch. 37. Government Act:

- "District of Sandy Point" means the District of Sandy Point, Abaco, as determined by the Minister under the provisions of the Local Government Act:
- "public place" includes any square, open place, wharf, pier, jetty, building or other place to which the public have access;
- "street" includes any road, street, sidewalk, footpath, alley, lane or thoroughfare;
- "vehicle" includes any motor car, carriage, cart, dray, wagon, tricycle, bicycle or other vehicle of two or more wheels, but does not include a baby carriage or perambulator.
- The provisions of these Regulations shall apply Application. to the Districts of Green Turtle Cay, Marsh Harbour and Sandy Point, Abaco, and shall be in addition to any of the
