ROAD TRAFFIC (PUBLIC SERVICE DRIVERS) (OMNIBUSES, TOUR CARS, LIVERY CARS AND TAXI CABS) (STANDARD OF APPEARANCE AND DRESS) REGULATIONS, 1992

(SECTION 38)

[Commencement 20th November, 1992]

Citation.

1. These Regulations may be cited as the Road Traffic (Public Service Drivers) (Omnibuses, Tour Cars, Livery Cars and Taxi Cabs) (Standard of Appearance and Dress) Regulations, 1992.

Interpretation.

2. In these Regulations "winter season" means that period commencing on the 15th day of December of each year and ending on the 15th day of April in the succeeding year.

Standard of dress during winter season.

- 3. (1) While driving passengers for hire or reward during the winter season, every driver of an omnibus, a tour car, a livery car or a taxi cab shall wear
 - (a) in the case of a male driver, a white or lightcoloured shirt with a collar designed for wearing a necktie, a necktie, and a dark pair of trousers; and
 - (b) in the case of a female driver, a white or light-coloured blouse or shirt with a collar designed for wearing a necktie, a necktie, and a dark skirt or a dark pair of trousers.
- (2) During the winter season a driver may also wear a coat or a jacket and a chauffeur's cap.

Standard of dress during other times of the year.

- 4. While driving passengers for hire or reward during any time of the year other than the winter season, every driver of an omnibus, a tour car, a livery car or a taxi cab may wear
 - (a) in the case of a male driver, a tropical print shirt and a light-coloured or a dark pair of trousers; and
 - (b) in the case of a female driver, a tropical print blouse or shirt and a light-coloured or a dark skirt or a light-coloured or a dark pair of trousers.

5. While driving passengers for hire or reward. every driver of an omnibus, a tour car, a livery car or a taxi cab -

Footwear and cleanliness.

- (a) shall wear shoes, other than sandals, slippers and tennis shoes; and
- (b) shall ensure that he or she is always clean and tidy in appearance.

Every driver of an omnibus, a tour car, a livery car or a taxi cab driver who fails without reasonable cause to comply with the prescribed standard of appearance and dress commits an offence and is liable on summary conviction to a fine not exceeding three hundred dollars.

1. These Regulations may be cited as the Road Traffic Citation. and Speed Limit (Eleuthera) Regulations.

2. In these Regulations, unless the context otherwise Interpretation. requires —
