## **APPROPRIATION (REVENUE ACCOUNT EXPENSES) (2017/2018) ACT, 2017**

**AN ACT FOR THE APPROPRIATION OF DIVERS SUMS OF MONEY  
FOR AND TOWARDS DEFRAYING THE EXPENSES OF THE  
GOVERNMENT OF THE COMMONWEALTH OF THE BAHAMAS ON  
REVENUE ACCOUNT FOR THE FINANCIAL YEAR COMMENCING  
1ST JULY, 2017 AND ENDING 30TH JUNE, 2018**

[Date of Assent - 30<sup>th</sup> June, 2017]

**Enacted by the Parliament of The Bahamas**

**1. Short title.**

This Act may be cited as the Appropriation (Revenue Account Expenses) (2017/2018) Act, 2017.

**2. Authority for payment.**

There may be paid out of the Treasury upon the authority of a warrant under the hand of the Minister of Finance during the financial year beginning on the 1st day of July, 2017 and ending on the 30th day of June, 2018 the several sums of money for defraying the recurrent expenses on revenue account for the public services of The Bahamas set forth in the Schedule.
