PRICE CONTROL ACT (CHAPTER 339)

PRICE CONTROL (GENERAL) (AMENDMENT) (NO. 4) REGULATIONS, 2023

The Minister, in exercise of the powers conferred by section 3 of the Price Control Act, makes the following Regulations —

1. Citation.

These regulations may be cited as the Price Control (General) (Amendment) (No. 4) Regulations, 2023.

2. Amends the Schedule to S.I. No. 18 of 1973.

The Schedule to the Price Control (General) Regulations is amended in Part 1 – Existing Items, by deleting, under sections 3 and 6 respectively, the maximum wholesale selling prices and maximum retail selling prices per package for product numbers 259, 261, 272, 276, 277 and 564; and substituting therefor the new prices for product numbers 259, 261, 272, 276, 277 and 564 as set out in Table 1.
