**LAW REFORM AND REVISION (MISCELLANEOUS
AMENDMENTS) ACT, 2011**

**AN ACT TO PROVIDE FOR CERTAIN MISCELLANEOUS
AMENDMENTS TO VARIOUS LAWS**

(Date of Assent - 1st June, 2011)

Enacted by the Parliament of The Bahamas

1. Short title and commencement.

- (1) This Act may be cited as the Law Reform and Revision (Miscellaneous Amendments) Act, 2011.
- (2) This Act shall be deemed to have come into force on the 31st day of December, 2009.

2. Amendments to miscellaneous written laws.

The written laws described in the first column of the *Schedule* are amended in the manner and to the extent set out in the second column of that *Schedule*.

“Part an III, etc.” and substitute the words “Part III, an”.

- (h) In paragraph 6 of the Second Schedule —
- (i) insert the words “In respect of the release of deposits —” immediately before paragraph (a) and alligned with subparagraph (2);
 - (ii) in subparagraph (2)(a), delete the word "his" and substitute the word "its";
 - (iii) in subparagraph (2)(b), delete the words “he” and “his” and substitute the words “it” and “its” respectively.
