TARIFF (AMENDMENT) ACT, 2020

AN ACT TO AMEND THE TARIFF ACT

[Date of Assent - 29th June, 2020]

Enacted by the Parliament of The Bahamas

1. Short title and commencement.

- (1) This Act may be cited as the Tariff (Amendment) Act, 2020.
- (2) This Act shall come into force on the 1st day of July, 2020.
