## BOAT REGISTRATION (YACHT) RULES, 1992

(SECTION 21)
[Commencement 2nd January, 1992]

1. These Rules may be cited as the Boat Registration (Yacht) Rules, 1992.
2. An applicant for a permit under section 4 of the Act shall submit to the New Providence Port Authority (hereinafter referred to as "the Authority") an application in Form 1 of the First Schedule containing the requisite particulars required by that Form.
3. (1) Where the Authority is satisfied that the approval of the application would be of benefit to The Bahamas and that the operator is of good character the Authority may cause to be issued to the applicant an annual permit subject to such conditions as the Authority sees fit to impose in the public interest.
(2) Subject to paragraph (3) a permit issued under paragraph (1) shall be in Form 2 of the First Schedule and shall expire on 31st December of the year in which it is issued unless sooner revoked.
(3) The Chairman of the Authority may where an applicant has in accordance with Rule 2 submitted an application and is desirous of obtaining permission to utilise a vessel for commercial purposes in The Bahamas pending the determination of that application issue a temporary permit in Form 3 of the First Schedule valid until a decision has been made by the Authority on that application.

Fees for application and permits

Revocation of permit
4. (1) There shall be payable in respect of an application for, and the issue of, a permit the respective fee set out in the Second Schedule.
(2) The fee specified in respect of an application shall accompany the application and is non-refundable.
(3) The fee payable for a permit shall be paid prior to the issue of the permit.
5. (1) A permit issued by the Authority may subject to paragraph (2) be revoked by it where the Authority is satisfied that -
(a) any condition to which the permit is subject has been breached; or
(b) the permit was issued based upon false information or a false statement made by the applicant; or
(c) that the operator of the vessel to which the permit relates has breached any law of The Bahamas by or during the operation of the vessel.
(2) The Authority shall prior to the revocation of an annual permit serve upon the holder of the permit a notice in writing specifying the ground upon which it is proposed to revoke the permit and inviting the holder to make representation as to why the permit should not be revoked.
(3) The Authority shall not revoke the permit until it is satisfied after receiving the written response from the holder that the permit should be revoked or after the holder has failed to respond.
(4) A notice mentioned in subparagraph (2) shall be considered as served if sent by pre-paid mail addressed to the holder at his address stated in the application for the permit.
6. (1) In addition to the fee set out in the Second Schedule, the owner or operator of a vessel carrying persons within The Bahamas pursuant to an agreement for hire of the vessel for that purpose and for which a permit is required shall pay to the Authority a sum equivalent to four per centum of the sum payable to that owner or operator in respect of that carriage.
(2) The sum payable under paragraph (1) shall if not paid previously become due and payable at the time the vessel enters the waters of The Bahamas or at the time the persons to be carried as referred to in that paragraph embark in The Bahamas for the commencement of their journey in The Bahamas, as the case may be.
(3) For the purpose of compliance with paragraph (2) the operator of the vessel shall submit at the port of entry or at the port at the time of commencement of the journey referred to in that paragraph to an officer of the Authority or of Customs a Form 4 in the First Schedule duly completed together with the requisite sum payable.
7. (1) The Authority when considering an application for a permit may request of the applicant any additional information as it sees fit.
(2) Any person who in any application, or upon being requested by the Authority, furnishes any information or makes any statement for the purpose of these Rules which he knows to be false in a material particular or recklessly furnishes information or makes a statement which is false in a material particular is guilty of an offence punishable on summary conviction by imprisonment for one year or by a fine of not less than one thousand dollars and not exceeding five thousand dollars or to both such imprisonment and fine.
(3) A court may upon conviction of a person of an offence under paragraph (2) in addition to the penalties mentioned therein order any vessel or sum in respect to which the false information or statement relates and which constituted the offence, to be forfeited or paid as the case may be.
8. (1) The operator of a vessel referred to in subsection (4) of section 4 who enters The Bahamas with passengers for the purpose of providing them for reward on that occasion facilities for scuba-diving shall, if not in
possession of a permit issued under these Rules on entering make application to the appropriate officer of the Port Authority or the Customs at the nearest point of entry and paying therefor the prescribed application and permit fees.
(2) An operator of a vessel referred to in paragraph (1) shall in addition pay at the time of the aforementioned entry -
(a) a fee of $\$ 50.00$ for each person being carried by the vessel on the trip; and
(b) a sum equivalent to four per centum of the sum payable by the passengers for the facilities being provided to them.
