**CIVIL AVIATION ACT
(CHAPTER 284)**

CIVIL AVIATION (SAFETY) (AMENDMENT) REGULATIONS, 2013

The Minister, in exercise of the powers conferred by section 5 of the Civil Aviation Act makes the following Regulations —

1. Citation.

These Regulations, which amend the Civil Aviation (Safety) Regulations¹, may be cited as the Civil Aviation (Safety) (Amendment) Regulations, 2013.

2. Amendment of Schedules to the principal Regulations.

The principal Regulations are amended by the repeal of existing Schedules 1 to 21 and the replacement with new Schedules 1 to 21 as follows —
