## CUSTOM MANAGEMENT ACT

(NO. 32 of 2011)

### CUSTOMS MANAGEMENT (AMENDMENT) REGULATIONS, 2015

The Minister in exercise of the powers conferred by section 354 and 355 makes the following Regulations—

**1. Citation and commencement.**

- (1) These Regulations, may be cited as the Customs Management (Amendment) Regulations, 2015.
- (2) These Regulations shall come into force on the 1<sup>st</sup> day of July, 2015.

**2. Amendment of paragraph 91 of the principal Regulations.**

Regulation 91(1) of the principal Regulations is amended—

- (a) in paragraph (a), by deleting the words and figures “two hundred and fifty dollars (\$250.00)” and substituting therefor the words and figures “one hundred and fifty dollars (\$150.00)”;
- (b) in paragraph (b), by deleting the words and figures “four hundred dollars (\$400.00)” and substituting therefor the words and figures “three hundred dollars (\$300.00)”.

**3. Amendment of paragraph 93 of the principal Regulations.**

Regulation 93(1) of the principal Regulations is amended in paragraph (b)(ii), by deleting the words and figures “one thousand dollars (\$1000.00) and substituting therefor the words and figures “five hundred dollars (\$500.00)”.

**4. Insertion of new regulation 150 into the principal Regulations.**

The principal Regulations are amended by inserting immediately after regulation 149, the following new regulation—

**“150. Fuel Surcharge and Security Fees.**

- (1) There is payable on the goods specified in the first column of the *Third Schedule* the surcharge or fees specified in the second column of that Schedule.

(2) The Minister may amend the *Third Schedule* by Order.”.

**5. Insertion of new Third Schedule into the principal Regulations.**

The principal Regulations are amended by inserting immediately after the Second Schedule, the following new Schedule —

**“THIRD SCHEDULE (Regulation 150)**

<b>GOODS</b>	<b>FEE/SURCHARGE</b>
Imported fuel, not including aviation fuel	1 cent per gallon
Every container imported into The Bahamas	\$10 per twenty-foot equivalent unit
Every container exported from The Bahamas	\$10 per twenty-foot equivalent unit
Every motor vehicle imported into The Bahamas	\$10
Every motor vehicle exported from The Bahamas	\$10.00

”.
