LIQUIDATION RULES, 2016**

The Liquidation Rules Committee, in exercise of the powers conferred by section 252 of the Companies Act, makes the following Rules —

1. Citation.

These Rules may be cited as the Foreign Proceedings (International Co-operation) (Relevant Foreign Countries) Liquidation Rules, 2016.

2. Interpretation.

In these Rules —

“Act” means the Companies Act (*Ch. 308*).

3. Designation of relevant foreign countries.

Pursuant to section 252 of the Act, each country listed in the *Schedule* is designated a relevant foreign country for purposes of Part VIIA of the Act.
