**LOCAL GOVERNMENT ACT
(CHAPTER 37)**

LOCAL GOVERNMENT (TOWN AREAS AND TOWN COMMITTEE MEMBERS) (AMENDMENT) ORDER, 2017

The Minister, in exercise of the powers conferred by sections 5(1) and 6(3) of the Local Government Act, makes the following Order —

1. Citation and commencement.

- (1) This Order may be cited as the Local Government (Town Areas and Town Committee Members) (Amendment) Order, 2017.
- (2) This Order is deemed to have come into force on the 26th day of May, 2017.

2. Amends the Schedule to S.I. No. 44 of 2017.
