At the Court at Buckingham Palace, the 11th day of March, 1959.

Present,

The Queen's Most Excellent Majesty in Council.

Whereas Her Majesty is satisfied that reciprocal provisions have been made by the legislature of the countries and territories specified in the First Schedule hereto for the enforcement within those countries and territories of maintenance orders made by courts within England and Northern Ireland:

Now, therefore, Her Majesty, by virtue and in exercise of the power conferred on Her by section 12 of the Maintenance Orders (Facilities for Enforcement) Act, 1920<sup>1</sup>, and section 19 of the Maintenance Orders Act, 1958<sup>2</sup>, and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

Application of Act.

Short title and interpretation.

**1.** The Maintenance Orders (Facilities for Enforcement) Act, 1920, shall extend to the countries and territories specified in the First Schedule hereto.

**2.** (1) This Order may be cited as The Maintenance Orders (Facilities for Enforcement) Order, 1959.

(2) The Interpretation Act, 1889<sup>3</sup>, shall apply for the purposes of interpreting this Order as it applies for the purpose of interpreting an Act of Parliament.
