PRICE CONTROL ACT (CHAPTER 339)

PRICE CONTROL (GENERAL) (AMENDMENT) (NO. 15) REGULATIONS, 2010

The Minister, in exercise of the powers conferred by section 3 of the Price Control Act, makes the following Regulations –

1. Citation.

These Regulations may be cited as the Price Control (General) (Amendment) (No. 15) Regulations, 2010.

2. Amends Part I of the Schedule to S.I. No. 18 of 1973.

Part I of the Schedule to the Price Control (General) Regulations, 1973 is amended –

- (a) in section 6 "FLOUR" by the insertion of the new article named "GOLD MEDAL" with its particulars as set out in PART B of the Schedule to these Regulations;
- (b) in section 10 "RICE" by the insertion of the new article named "JAMAICA BAHAMAS" with its particulars as set out in PART B of the Schedule to these Regulations.
