**PRICE CONTROL (GENERAL) (AMENDMENT) (NO. 15)  
REGULATIONS, 2010**

The Minister, in exercise of the powers conferred by section 3 of the Price Control Act, makes the following Regulations –

**1. Citation.**

These Regulations may be cited as the Price Control (General) (Amendment) (No. 15) Regulations, 2010.

**2. Amends Part I of the Schedule to S.I. No. 18 of 1973.**

Part I of the Schedule to the Price Control (General) Regulations, 1973 is amended –

- (a) in section 6 - “**FLOUR**” - by the insertion of the new article named “**GOLD MEDAL**” with its particulars as set out in **PART B** of the Schedule to these Regulations;
- (b) in section 10 - “**RICE**” - by the insertion of the new article named “**JAMAICA BAHAMAS**” with its particulars as set out in **PART B** of the Schedule to these Regulations.
