**PRICE CONTROL ACT  
(CHAPTER 339)**

**PRICE CONTROL (GENERAL) (AMENDMENT) (NO. 2)  
REGULATIONS, 2024**

The Minister in exercise of the powers conferred by section 3 of the Price Control Act, makes the following Regulations —

**1. Citation.**

These Regulations may be cited as the Price Control (General) (Amendment) (No. 2) Regulations, 2024.

**2. Amends the Schedule to S.I. No. 18 of 1973.**

The Schedule to the Price Control (General) Regulations, is amended in —

- (a) Part 1 – Existing Items, by deleting, under sections 3 and 11, the maximum wholesale selling prices and maximum retail selling prices per package for product numbers 320, 329, 1316, 1317, 1318 and 1336 and substituting therefor the new prices for product numbers 320, 329, 1316, 1317, 1318 and 1336 as set out in Table 1.
- (b) Part 2 – New Items, by inserting the name, description and prices of new items as set out in Table 2.
