**PRICE CONTROL (GENERAL) (AMENDMENT) (NO. 7)
REGULATIONS, 2022**

The Minister in exercise of the powers conferred by section 3 of the Price Control Act, makes the following regulations —

1. Citation.

These regulations may be cited as the Price Control (General) (Amendment) (No. 7) Regulations, 2022.

2. Amends the Schedule to S.I. No. 18 of 1973.

The Schedule to the Price Control (General) Regulations is amended in Part 1 – Existing Items, by deleting, under section 3 the maximum wholesale selling prices and maximum retail selling prices per package for product numbers 286, 306 and 307; and substituting therefor the new prices for product numbers 286, 306 and 307 as set out in Table 1.
