ROAD TRAFFIC ACT (CHAPTER 220)

ROAD TRAFFIC (AMENDMENT) REGULATIONS, 2013

The Minister, in exercise of the powers conferred by section 93 of the Road Traffic Act, makes the following regulations –

1. Citation and commencement.

- (1) These regulations, which amend the Road Traffic Regulations¹ may be cited as the Road Traffic (Amendment) (No. 2) Regulations, 2013.
- (2) These regulations shall come into force on the 5th July, 2013.

2. Amends Regulation 11 of the principal Regulations.

Regulation 11 of the principal Regulations is amended as follows –

- (a) at paragraph (1), by deleting subparagraph (s) and substituting therefor the following –
“ (s) Market Street between Robinson Road and Duke Street.”;
- (b) at paragraph (2), by deleting subparagraph (w) and substituting therefor the following –
“(w) Baillou Hill Road between Cumberland Street and Robinson Road.”;
- (c) at paragraph (3), by –
 - (i) deleting the words “Cambridge Lane” at subparagraph (b), and substituting therefor the words “Dunmore Street between Hospital Lane and Market Street”;

- (ii) deleting the full-stop at the end of subparagraph (s), and substituting therefor a semi-colon; and
- (iii) inserting, immediately after subparagraph (s), the following as new subparagraphs (t), (u), (v), (w) and (x) –
 - “(t) Peter Street between Baillou Hill Road and Market Street;
 - (u) Chapel Street between Baillou Hill Road and Market Street;
 - (v) King Street between Hospital Lane and Baillou Hill Road;
 - (w) Weir Street between Hospital Lane and Baillou Hill Road;
 - (x) Bias Corner between Hospital Lane and Baillou Hill Road.”; and
- (d) at paragraph (4), by –
 - (i) deleting the full stop at the end of subparagraph (s), and substituting therefor a semi-colon; and
 - (ii) inserting, immediately after subparagraph (s), the following as new subparagraphs (t), (u), (v), (w), (x) and (y) –
 - “(t) Windsor Road between East Street and Market Street;
 - (u) Deveaux Street between East Street and Market Street;
 - (v) Laird Street between Market Street and Baillou Hill Road;
 - (w) King Street between Market Street and Baillou Hill Road;
 - (x) Vesey Street between Market Street and Baillou Hill Road;
 - (y) Cambridge Lane between Baillou Hill Road and Hospital Lane.”.
