OPTION CLAUSE

The Boxer agrees to grant the Promoter an option of two further contests under the same terms and conditions, both to take place within seven weeks of the content provided for at clause 1, provided that —

- (a) the option is taken up by the Promoter within two days of the contest provided for at clause 1;
- (b) the first such further contest shall take place within three weeks of the original contest;
- (c) the Promoter within two days after the first such further contest shall fix the date of the second optional contest;
- (d) the opponent in both such further contests shall be mutually agreed upon and in the event of the parties being unable to reach agreement the matter shall be referred to the Commission, whose decision shall be final; and
- (e) in the event of the option being taken up and the money received being a “percentage” sum, the Boxer agrees not to box elsewhere until this contract is fulfilled.

**SPORTS (ADVISORY COUNCILS) RULES**

*SI 82/1965*

(SECTION 11)

*[Commencement 3rd April, 1965]*

**1.** These Rules may be cited as the Sports Title  
(Advisory Councils) Rules.

**2.** In these Rules, unless the context otherwise Interpretation  
requires —

---

“Sports Commissioner” means the person appointed to assist the Minister under the provisions of section 7 of the Sports Act.

Appointment  
and membership  
of advisory  
councils

**3.** (1) The Minister may appoint such advisory councils as he thinks necessary to advise him in regard to any particular sport or recreation.

(2) An advisory council shall be appointed for such period not exceeding twelve months at one time as the Minister may deem necessary.

(3) An advisory council shall consist of such number of persons, not being less than three, as the Minister may in each case determine. The members shall be appointed by the Minister and one of their number shall be designated chairman of the council.

(4) In the exercise of his functions under the provisions of this rule the Minister shall act after consultation with the Sports Commissioner.

Quorum and  
procedure

**4.** (1) The quorum at all meetings of an advisory council shall be three members.

(2) All questions coming or arising before a meeting of an advisory council shall be decided by a majority of members present and voting thereon and in the case of an equality of votes the person presiding shall have a second or casting vote.

(3) Save as specifically mentioned in these Rules an advisory council may govern its own procedure.
