# THE PAROCHIAL ELECTIONS (MODIFICATION) ACT \*

[15th November, 1979.]

Act 30 of 1979.

- 1. This Act may be cited as the Parochial Elections Short title. (Modification) Act.
- 2. This Act shall continue in force until the expiry of Duration the Representation of the People (Interim Electoral Reform) Act, and shall then expire.
- 3. During the continuance in force of this Act the Application provisions of sections 2(2), 5, 6, 7, 10 and 12 of the Representation of the People (Interim Electoral Reform) Act, shall have effect with regard to elections pursuant to the provisions of the Kingston and St. Andrew Corporation Act. Reform Act. and the Parish Councils Act respectively (hereinafter referred to as the Parochial Acts) as they have effect with regard to elections pursuant to the Representation of the People Act, and accordingly—

- (a) any reference to the Chief Electoral Officer in either of the Parochial Acts shall be deemed to be a reference to the Director of Elections; and
- (b) any reference to any other election officer in either of the Parochial Acts shall be deemed to be a reference to the appropriate person appointed and designated for the purpose pursuant to section 10 of the Representation of the People (Interim Electoral Reform) Act.

# Electoral Divisions.

- 10—(1) For the purpose of this Act there shall be constituted in each parish except the parishes of Kingston and St. Andrew so many electoral divisions as the Electoral Advisory Committee established under the Representation of the People (Interim Electoral Reform) Act may determine.
- (2) Every electoral division shall comprise so many and such polling divisions as the Committee may by order direct.
