AN ACT to Apply a sum out of the Consolidated Fund to the service of the year ending on the 31st day of March, 2009 and to appropriate the sums granted in this Session of Parliament.

BE IT ENACTED by The Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Representatives of Jamaica, and by the authority of the same, as follows:—

1. This Act may be cited as the Appropriation Act, 2008.
