AN ACT to apply a sum out of the Consolidated Fund to the service of the year ending on the 31st day of March, 2016 and to appropriate the sums granted in this Session of Parliament.

[April 1, 2015]

BE IT ENACTED by The Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Representatives of Jamaica, and by the authority of the same, as follows:—

1. This Act may be cited as the Appropriation Act, 2015.

Expenditure Authorised.

2. The Accountant-General may, on the warrant of the Minister, issue out of the Consolidated Fund, a sum not exceeding in the aggregate, Three Hundred and Eleven Thousand, Three Hundred and Fifty-one Million, Five Hundred and Seventy-eight Thousand Dollars for defraying the several charges and expenses of the Government of Jamaica, and for other purposes, for the financial year ending on the 31st day of March, 2016.

Appropriation. Schedule.

- 3.—(1) The sum granted by section 2 is hereby appropriated for the services and purposes specified in the first column of the Schedule, pursuant to and in accordance with subsection (1) of section 116 of the Constitution of Jamaica and the second column of the Schedule shall be deemed to have been so appropriated from the 1st day of April, 2015.
- (2) In addition to the said sum granted out of the Consolidated Fund, accounting officers may apply out of any money, whether received by way of fee, penalty, proceeds of sale, or by way of extra or unusual receipt, as appropriations-in-aid of the services and purposes specified in the first column of the Schedule, the sums respectively set out in the third column of the Schedule.
