(Made by the Minister on the 3rd day of December, 1999)

- 1. These Regulations may be cited as the Administrator-General's (Fees) Regulations, 1999.
- 2. The fees specified in Column II of the Schedule are payable in respect of schedule the services specified in Column I thereof which are undertaken by the Administrator-General's Department.
- 3.—(1) A person who is unable to pay any fee specified in the Schedule may apply to the Administrator-General for a waiver from the payment of such fee.
- (2) The Administrator-General may grant a waiver to a person who satisfies him as to his inability to pay the fee.
 - (3) The Administrator-General shall cause to be kept a record of—
 - (a) the name and address of the person to whom a waiver is granted;
 - (b) the service in respect of which the waiver of the fee is granted;
 - (c) the amount of the fee waived.
