THE CRIMINAL JUSTICE (ADMINISTRATION) (RESTRICTED PERSONS)  
REGULATIONS, 1996

(Made by the Minister on the 3rd day of December, 1996)

1. These Regulations may be cited as the Criminal Justice (Administration) (Restricted Persons) Regulations, 1996.

2. The Order for the designation pursuant to section 54B of a restricted person shall be in the form specified as Form A in the Schedule.

3. The central register and parish register of restricted persons to be kept pursuant to sections 54D and 54E respectively, shall be in the forms specified respectively as Forms B and C in the Schedule.

4. The registration certificate to be issued to a restricted person pursuant to section 54E shall be in the form specified as Form D in the Schedule.

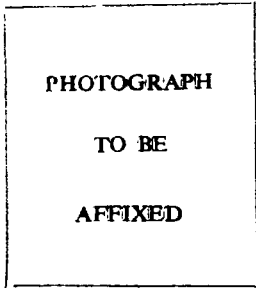
