1. These Regulations may be cited as the Deputy Clerks of the Courts (Qualification) Regulations, 1944.

2. In these Regulations—

Interpretation.

“approved university” means a university in the Commonwealth approved by the Chief Justice;

“specified subjects” means the subjects specified in the First Schedule.

3. Except as otherwise provided by paragraph (a) of subsection (1) of section 22 of the Act, no person shall be qualified to be appointed a Deputy Clerk of the Courts unless he has passed the final examination for the degree of Bachelor of Laws or for any equivalent Bachelor's degree in Law of an approved university or unless he has passed an examination set by or under the direction of the Chief Justice in the subjects specified in the First Schedule:

Provided that no person shall be required to take an examination in any of the specified subjects in which he has passed in one of the examinations specified in the Second Schedule.

DEBTS) ORDER, 1999

1. This Order may be cited as the Judicature (Parish Courts) (Rate of Interest on Judgment Debts) Order, 1999.

2. The rate of interest payable on every judgment debt shall be twelve *per centum* per annum.
