1. This Order may be cited as the Loans (Canada and United States of America and Other Specified Countries) (United Kingdom) (Application) Order, 1963.

2. The Act shall be applicable to the raising of loans in the United Kingdom, subject to the modifications specified in the Schedule.

SCHEDULE

(Paragraph 2)

Enactment

Modification

In the definition of "country of issue" appearing in subsection (1) of section 2, and in subsection (1) of section 5.

The reference to Canada and the United States of America or to both such countries shall be construed as references to the United Kingdom.

In subsection (1) of section 5.

The reference to dollars shall be construed to include pounds sterling.

In subsection (2) of section 5.

The reference to Stock Exchanges in the country of issue shall be construed to include Stock Exchanges in such countries as the Minister deems fit.
