THE LOCAL INDUSTRIES (SAFEGUARDING) REGULATIONS, 1966

(Made by the Minister on the 10th day of June, 1966)

L.N. 173/66

- 1. These Regulations may be cited as the Local Industries (Safeguarding) Regulations, 1966.
- 2.—(1) The period within which objections may be lodged under subsection (4) of section 4 of the Act shall be—
  - (a) in the case of an authority to whom the Minister's proposal has been referred under paragraph (b) of subsection (3) of the said section 4, within twenty-one days of the reference;
  - (b) in the case of a person upon whom a copy of a notice has been served under paragraph (c) of subsection (3) of the said section 4, within twenty-one days after the service on such person of the notice; and
  - (c) in the case of any other person, within seven days after the last publication of the notice required to be published under paragraph (a) of subsection (3) of the said section 4.
- (2) When the Minister has appointed a committee in accordance with subsection (4) of the said section 4, he shall notify the objector of such appointment and of the date and time when, and the place where, the committee will meet to enquire into and consider the objection.
- 3. The prescribed fee in respect of an application for a licence under the Act shall be \$2.10.
- 4. Where an objection has been lodged under subsection (2) of section 5, the Minister shall notify the objector of the date and time when, and place where, he is to appear and oppose the grant of the licence to which his objection relates.
- 5. A licence granted under the Act shall be in the form set out in the Schedule.

- 6. Proper books of account shall be kept by every licensee in respect of the operation of each of his factories and the Collector of Taxes and any person authorized in writing by the Collector or by the Minister shall have access to such books at all reasonable times.
