THE METAL AND JEWELLERY (SECOND-HAND) (FORMS) REGULATIONS,
1947

(Made by the Governor in Executive Council on the 28th day of March, 1947) L.N. 20/47

1. These Regulations may be cited as the Metal and Jewellery (Second-hand) (Forms) Regulations, 1947.

2. The form of application for a licence to deal in second-hand metal or in second-hand jewellery shall be in the Form A in the Schedule. Form A.

3. The form of licence to deal in second-hand metal or in second-hand jewellery shall be in the Form B in the Schedule. Form B.

4.—(1) Every person licensed under the Act to deal in second-hand metal shall keep a Purchases Book and a Sales Book.

(2) Every person licensed under the Act to deal in second-hand jewellery shall keep a Purchases Book and a Sales Book.

(3) Every Purchases Book shall specify—

- (a) the nature and quantity of the article purchased;
- (b) the name and address of the person from whom the article was purchased;
- (c) the date and hour at which such purchase was made;
- (d) whether the vendor was known or was identified to the licensee;
- (e) if the vendor was identified, the name of the person identifying such vendor;
- (f) the price paid for such article.

**THE METAL AND JEWELLERY (SECOND-HAND) (FORMS)
REGULATIONS, 1947**

- (4) Every Sales Book shall specify—
 - (a) the name and address of the person to whom the article was sold;
 - (b) the date and hour at which the sale was made;
 - (c) the price paid for such article;
 - (d) the date upon which the article had been purchased by the licensee and the person from whom it was purchased.
