# Supplementary Appropriation (No. 3) Act, 2011

#### 1. Short title and commencement

This Act may be cited as the Supplementary Appropriation (No. 3) Act 2011, and is deemed to have come into force on the first day of April, 2011.

### 2. Authorisation of Expenditure

The various sums of money set forth in Schedules A and B to this Act, totalling sixty three thousand seven hundred dollars (\$63,700) in addition to the sums granted by the Appropriation Act 2011 (No. 2 of 2011), are hereby declared to be charged upon and made payable from the Consolidated Fund of Montserrat, and the Accountant General is hereby authorised and required from time to time upon the authority of warrants issued under the hand of the Minister of Finance to pay the said sums set out in the said Schedule to several services therein mentioned as the warrants may direct out of the Consolidated Fund of Montserrat without further order or formality.
