BIS-SAHHA tas-setgħat mogħtija lilu bl-artikoli 30 (5) u 31 (6) ta' l-Att dwar l-Edukazzjoni (Kap. 327), il-Kanċillier ta' l-Universita' ta' Malta ppromulga dawn ir-regolamenti magħmula mis-Senat ta' l-Universita' ta' Malta bis-saħha tas-setgħat mogħtija lilu bl-artikoli 31 u 35 ta' dak l-Att:

Titolu

1. Dawn ir-regolamenti jistgħu jissejhu r-Regolamenti ta' l-2003 biex jemendaw ir-Regolamenti għall-Kors tad-Diploma in Management Studies - Dip. Mangt. - u għandhom jinqraw u jinftiehm bħala haġa waħda mar-Regolamenti ta' l-1996 għall-Kors tad-Diploma in Management Studies - Dip. Mangt. - ippubblikati bħala Avviż Legali 68 ta' l-1996, li minn hawn 'il quddiem jissejhu "ir-regolamenti prinċipali".

Applikabilita'

2. Dawn ir-regolamenti għandhom japplikaw minn Ottubru 2002 'il quddiem.

Emenda għar-regolament 7 tar-regolamenti prinċipali

3. Minflok il-paragrafu (1) tar-regolament 7 tar-regolamenti prinċipali għandu jidhol dan li ġej:

"7. (1) Kull student għandu jkun meħtieġ jikteb Essay ta' madwar 5,000 kelma fuq sugġett approvat maħsub biex juri kemm l-istudent hu kapaċi jintegra d-diversi aspetti tal-kors ta' studju. L-essay huwa assenjat żewġ krediti."

**EDUCATION ACT
(CAP. 327)**

**Diploma in Management Studies - Dip. Mangt. - Course (Amendment)
Regulations, 2003**

IN exercise of the powers conferred upon him by sections 30(5) and 31(6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following regulations made by the Senate of the University of Malta by virtue of the powers conferred upon it by sections 31 and 35 of the said Act:

Citation

1. These regulations may be cited as the Diploma in Management Studies - Dip. Mangt. - Course (Amendment) Regulations, 2003 and shall be read and construed as one with the Diploma in Management Studies - Dip. Mangt. - Course Regulations, 1996, published as Legal Notice 68 of 1996, hereinafter referred to as "the principal regulations".

Applicability

2. These regulations shall be applicable from October 2002.

Amendment of regulation 7 of the principal regulations

3. For paragraph (1) of regulation 7 of the principal regulations there shall be substituted the following:

"7. (1) Each candidate shall be required to write an Essay of approximately 5,000 words on an approved topic intended to illustrate the student's ability to integrate the various aspects of the course of studies. Two credits shall be assigned to the writing of the essay."
