EDUCATION ACT (CAP. 327)

Diploma in Nursing and Diploma in Midwifery Course (Amendment) Regulations, 2003

IN exercise of the powers conferred upon him by sections 30 (5) and 31 (6) of the Education Act (Cap. 327), the Chancellor of the University of Malta has promulgated the following regulations made by the Senate of the University of Malta by virtue of the powers conferred upon it by sections 31 and 35 of the said Act:

Citation

1. These regulations may be cited as the Diploma in Nursing and Diploma in Midwifery Course (Amendment) Regulations, 2003 and shall be read and construed as one with The Diploma in Nursing and Diploma in Midwifery - Course Regulations, 1999 published as Legal Notice 105 of 1999, hereinafter referred to as "the principal regulations".

Applicability

 $\,$ 2. These regulations shall apply to courses starting in October 2002 or later.

Amendment of regulation 7 of the principal regulations

- 3. The following paragraph (4) shall be added after paragraph (3) of regulation 7 of the principal regulations:
- "(4) Before the commencement of the Diploma Programme, students opting for Midwifery Studies or Psychiatric Nursing as their area of study shall be reassessed for their suitability to follow their chosen area of study."
