**Notice of coming into force of the Protection of
Birds and Wild Rabbit (Amendment) Regulations, 2003**

BY virtue of the powers conferred on him by article 9 of the Environment Protection Act, 2001 and by regulation 1 of the Protection of Birds and Wild Rabbit (Amendment) Regulations, 2003, hereinafter referred to as the "amending regulations", the Minister for Home Affairs and the Environment has established the 1st February, 2003, as the date when the Protection of Birds and Wild Rabbit (Amendment) Regulations, 2003, shall come into force other than paragraph (3) of new regulation 2B introduced by regulation 3 of the amending regulations except for the provision that no new licences to take, are to be issued before the 31st December, 2007, and other than paragraph (c) of regulation 9 of the amending regulations:

and furthermore by virtue of the powers conferred on him by the paragraph (d) of regulation 13 of the amending regulations, the said Minister has established the 31st May 2003, as the prescribed date for the registration of stuffed birds.
