ARRANGEMENT OF CLAUSES

Clause

1. Short title
2. Appropriation for the service of the Mauritius Government.
3. Provision for Capital Development.

A BILL

To make provision for the service of the Mauritius Government and for **Capital** Development for the financial year 2002-2003.

ENACTED by the Parliament of Mauritius, as follows -

1. **Short title**

This Act may be cited as the Appropriation (2002-2003) Act 2002.

2. Provision for the Service of the Mauritius Government

- (1) A sum not exceeding thirty-two billion six hundred and thirty million rupees shall be and is hereby charged upon the Consolidated Fund for the service of the Mauritius Government for the financial year 2002-2003.
- (2) The expenditure of the said sum shall be in conformity with the Schedule to this Act.

3. Provision for Capital Development

A sum not exceeding nine billion and one hundred and thirty million rupees shall be and is hereby charged on the sums -

- (a) in the Capital Fund as at 1 July 2002; and
- (b) receivable into the Capital Fund at anytime thereafter,

to defray the cost of works and other charges of capital development.
