# A BILL

To make provision for the service of the Mauritius Government and for Capital Development for the financial year 2003-2004

ENACTED by the Parliament of Mauritius, as follows-

#### 1. Short title

This Act may be cited as the Appropriation (2003-2004) Act 2003.

## 2. Provision for the Service of the Mauritius Government

- (1) A sum not exceeding thirty six billion seven hundred and fifty million rupees shall be and is hereby charged upon the Consolidated Fund for the service of the Mauritius Government for the financial year 2003-2004.
- (2) The expenditure of the said sum shall be in conformity with the Schedule to this Act

## 3. Provision for Capital Development

A sum not exceeding nine billion one hundred million rupees shall be and is hereby charged on the sums –

- (a) in the Capital Fund as at 1 July 2003; and
- (t) receivable into the Capital Fund at anytime thereafter,

to defray the cost of works and other charges of capital development.
