ARRANGEMENT OF CLAUSES

Clause

1. Short title
2. Appropriation of excess expenditure for 2002-2003

A BILL

To apply for a further sum of One billion two hundred and eighty-three million five hundred and forty-two thousand seven hundred and five rupees (Rs. 1,283,542,705) to the service of the financial year 2002-2003

ENACTED by the Parliament of Mauritius, as follows: -

1. Short title

This Act may be cited as the Supplementary Appropriation (2002-2003) Act 2004.

2. Appropriation of excess expenditure for 2002-2003

The sum of One billion two hundred and eighty-three million five hundred and forty-two thousand seven hundred and five rupees (Rs. 1,283,542,705) consisting of the amounts specified in the Schedule, which was duly paid and applied to the services of the Government during the year 2002-2003, is declared to have been validly paid out of the Consolidated Fund.
