

# Baking Industry (Remuneration) (Amendment) Regulations 2022

## THE EMPLOYMENT RELATIONS ACT

### Regulations made by the Minister under section 94 of the Employment Relations Act

1. These regulations may be cited as the **Baking Industry (Remuneration) (Amendment) Regulations 2022**.
2. In these regulations -  
“principal regulations” means the Baking Industry (Remuneration) Regulations 2019.
3. Regulation 2 of the principal regulations is amended -
  - (a) in the definition of “team”, in paragraph (c), by deleting the words “3 unskilled employees;” and replacing them by the words “3 mechanised bakery helpers.”;
  - (b) by deleting the definition of “unskilled employee”;
  - (c) by inserting, in the appropriate alphabetical order, the following definitions -  
“biscuit factory helper” means an employee, commonly known as *manoeuvre* or helper, who is required to perform any casual piece of work in a biscuit factory;  
“mechanised bakery helper” means an employee, commonly known as *manoeuvre* or helper, who is required to perform any casual piece of work in a mechanised bakery;  
“pastry bakery helper” means an employee, commonly known as *manoeuvre* or helper, who is required to perform any casual piece of work in a pastry bakery;  
“SME” has the same meaning as in the Small and Medium Enterprises Act;
4. Regulation 4 of the principal regulations is amended -
  - (a) by revoking paragraph (3) and replacing it by the following paragraph -
    - (3) The rates specified in the Second Schedule include -
      - (a) the appropriate national minimum wage payable under the National Minimum Wage Regulations 2017;
      - (b) the additional remuneration payable under the Workers' Rights (Additional Remuneration) (2020) Regulations 2019;

- (c) the additional remuneration payable under the Workers' Rights (Additional Remuneration) (2021) Regulations 2021; and
- (d) the additional remuneration payable under the Workers' Rights (Additional Remuneration) (2022) Regulations 2022.

(b) by inserting, after paragraph (3), the following new paragraph -

(3A) (a) Every employee shall, subject to any forthcoming additional remuneration payable under the Additional Remuneration Regulations, be remunerated at the rate specified in the Second Schedule.

(b) An employee employed in an enterprise, other than an SME, shall, for the period starting on -

- (i) 1 January 2022, be remunerated as specified in Column I;
- (ii) 1 July 2022, be remunerated as specified in Column II;
- (iii) 1 July 2023, be remunerated as specified in Column III,

of the Second Schedule.

(c) An employee employed in an SME shall, for the period starting on -

- (i) 1 January 2022, be remunerated as specified in Column I;
- (ii) 1 July 2023, be remunerated as specified in Column III,

of the Second Schedule.

**5.** Regulation 5 of the principal regulations is amended by deleting the words “an unskilled employee or a” and replacing them by the words “a biscuit factory helper, mechanised bakery helper, pastry bakery helper or”.

**6.** The principal regulations are amended by adding the following new regulations -

**9.** For the purpose of determining the basic daily rate of an employee, except where expressly provided, a month shall, where an employee is employed on -

- (a) a 6-day week, be deemed to consist of 26 days; and
- (b) a 5-day week, be deemed to consist of 22 days.

**10.** The monthly basic wage payable to a migrant employee shall, subject to the appropriate national minimum wage payable under the National Minimum Wage Regulations 2017, be as specified in Column I, II or III of the Second Schedule, as may be applicable, less any difference in the amount of additional remuneration payable under the Workers' Rights (Additional Remuneration) (2020) Regulations 2019.

7. The Second Schedule to the principal regulations is revoked and replaced by the Second Schedule set out in the Schedule to these regulations.

8. These regulations shall be deemed to have come into operation on 1 January 2022.
