THE CONSTRUCTION INDUSTRY DEVELOPMENT BOARD ACT

Regulations made by the Minister, after consultation with the Construction Industry Development Council, under section 34 of the Construction Industry Development Board Act

- 1. These regulations may be cited as the Construction Industry Development Board (Compliance Notice and Penalty Fees) Regulations 2022.
- 2. In these regulations
 - "Act" means the Construction Industry Development Board Act.
- **3.** For the purpose of section 25A(2)(b) of the Act, the compliance notice shall be in the form set out in the First Schedule.
- **4.** For the purpose of section 25A(5)(a) of the Act, where the Council grants an application for registration, the applicant shall, in addition to the appropriate registration fee, pay the appropriate penalty fee specified in the Second Schedule.
- **5.** These regulations shall be deemed to have come into operation on 1 January 2022.
