THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

Regulations made by the Minister under section 35 of the Consumer Protection (Price and Supplies Control) Act

- 1. These regulations may be cited as the Consumer Protection (Control of Imports) (Amendment No. 2) Regulations 2024.
- 2. In these regulations -
 - "principal regulations" means the Consumer Protection (Control of Imports) Regulations 2017.
- **3.** Regulation 2 of the principal regulations is amended by inserting, in the appropriate alphabetical order, the following new definition -

"road racing" has the meaning assigned to it in section 125 of the Road Traffic Act;

- **4.** Regulation 4 of the principal regulations is amended, in paragraph (3)(a), by deleting the words "rally purposes" and replacing them by the words "the purpose of road racing".
- **5.** The Ninth Schedule to the principal regulations is revoked and replaced by the Ninth Schedule set out in the Schedule to these regulations.
- **6.** These regulations shall come into operation on 18 July 2024.
