THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

Regulations made by the Minister under section 35 of the Consumer Protection (Price and Supplies Control) Act

1. These regulations may be cited as the **Consumer Protection (Control of Imports) (Amendment No. 4) Regulations 2015**.

2. In these regulations —

“principal regulations” means the Consumer Protection (Control of Imports) Regulations 1999.

3. The First Schedule to the principal regulations is amended by adding the following items and their corresponding entries —

Note— The HS codes above are indicative and basket items. The HS codes also cater for sacks and bags of plastics other than those captured at sub-headings 3923.211, 3923.212, 3923.291 and 3923.292, that is, plastic carrier bags with or without handles and with or without gussets.
