

**Consumer Protection (Control of Imports) (Amendment No. 5) Regulations 2015**

**THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT**

**Regulations made by the Minister under section 35 of the Consumer Protection (Price and Supplies Control) Act**

1. These regulations may be cited as the **Consumer Protection (Control of Imports) (Amendment No. 5) Regulations 2015**.

2. In these regulations —

“principal regulations” means the Consumer Protection (Control of Imports) Regulations 1999.

3. The First Schedule to the principal regulations is amended by deleting the following items and their corresponding entries —

Note-

The HS codes above are indicative and basket items. The HS codes also cater for sacks and bags of plastics other than those captured at sub-headings 3923.211, 3923.212, 3923.29 and 3923.292, that is, plastic carrier bags with or without handles and with or without gussets.

4. The Fifth Schedule to the principal regulations is amended by deleting the following items and their corresponding entries —

30. Any plastic bag which is a bag designed to be used for the disposal of waste
31. Any plastic bag which is a bag designed for agricultural purposes
32. Any plastic bag which is a bag used for the purpose of sampling or analysis (2) Clearance from the Director of Environment
33. Any plastic bag which is a bag that constitutes, or forms an integral part of, the packaging in which goods are sealed prior to sale on the local market or for export
34. Any plastic bag which is a transparent pocket type bag not exceeding 300 square centimetres in size
35. Any plastic bag which is a transparent resealable bag with security tamper used by a passenger to contain liquids, aerosols or gels at an airport or on board of an aircraft or carried

by a transfer passenger

36. Any plastic bag which is a bag carried by a passenger disembarking from an aircraft or a ship for the purpose of carrying personal belongings

37. Any plastic bag which is a bag manufactured for export

5. These regulations shall be deemed to have come into operation on 10 September 2015.
