**Regulations made by the Minister under sections 3 and 35 of  
the Consumer Protection (Price and Supplies Control) Act**

- 1.** These regulations may be cited as the Rodrigues **Consumer Protection (Control of Price of Taxable and Non-taxable Goods) (Amendment No. 4) Regulations 2022**.
- 2.** In these regulations -  
  
"principal regulations" means the Rodrigues Consumer Protection (Control of Price of Taxable and Non-taxable Goods) Regulations 1998.
- 3.** The Third Schedule to the principal regulations is revoked and replaced by the Third Schedule set out in the Schedule to these regulations.
- 4.** These regulations shall come into operation on 9 March 2022.
