### **THE CUSTOMS TARIFF ACT**

#### **Regulations made by the Minister under section 15 of the Customs Tariff Act**

- 1.** These regulations may be cited as the **Customs Tariff (Amendment of Schedule) (No. 4) Regulations 2014**.
- 2.** In these regulations –  
  
“Act” means the Customs Tariff Act;  
  
“item” includes the entries corresponding to the item.
- 3.** The First Schedule to the Act is amended, in Part I –
  - (a) by deleting the items specified in Part A of the Schedule to these regulations;  
and
  - (b) by inserting, in the appropriate numerical order, the items specified in Part B of the Schedule to these regulations.
- 4.** These regulations shall come into operation on 1 January 2015.
