Central Water Authority (Water Supply for Domestic Purposes) (Amendment) Regulations 2016

THE CENTRAL WATER AUTHORITY ACT

Regulations made by the Central Water Board, with the approval of the Minister, under section 49 of the Central Water Authority Act

1. These regulations may be cited as **Central Water Authority (Water Supply for Domestic Purposes) (Amendment) Regulations 2016**.

2. In these regulations -

"principal regulations" means the Central Water Authority (Water Supply for Domestic Purposes) Regulations 2011.

3. Regulation 9 of the principal regulations is amended by revoking paragraph (6) and replacing it by the following paragraph -

(6) (a) Every consumer consuming 6 cubic metres or less of water, under Tariff9, shall be exempted from the payment of meter rent

(b) Every consumer shall, unless exempted by the Authority; pay the meter rent specified in Part B of the First Schedule.

- **4.** Regulation 15 of the principal regulations is amended
 - (a) by revoking paragraph (2) and replacing it by the following paragraph -

(2) Every consumer shall pay the water charge as specified in Part D of the First Schedule unless he has given at least one month's written notice, in the form set out

in the Third Schedule, to the Authority to have his water supply disconnected.

(b) in paragraph (3)(b), by deleting the words "minimum water charge" and replacing them by the words "water charge specified in Part D of the First Schedule".

5. The First Schedule to the principal regulations is amended by deleting Part D and replacing it by Part D set out in the Schedule to these regulations.

6. These regulations shall be deemed to have come into operation on 1 January 2016.
