THE ECONOMIC DEVELOPMENT BOARD ACT

Regulations made by the Minister under section 40 of the Economic Development Board Act

1. Short title

These regulations may be cited as the **Economic Development Board (Processing Fees) Regulations 2024**.

2. Interpretation

In these regulations -

"IHS" means the Invest Hotel Scheme set up under the Economic Development Board (Invest Hotel Scheme) Regulations 2015;

"IRS" means the Integrated Resort Scheme referred to in the Economic Development Board (Real Estate Development Scheme) Regulations 2022;

"PDS" means the Property Development Scheme set up under the Economic Development Board (Property Development Scheme) Regulations 2015;

"RES" means the Real Estate Scheme referred to in the Economic Development Board (Real Estate Development Scheme) Regulations 2022;

"SCS" means the Smart City Scheme set up under the Economic Development Board (Smart City Scheme) Regulations 2015.

3. Processing fees

- (1) An application specified in the second column of the Schedule shall be accompanied by the corresponding non-refundable processing fee specified in the third column of the Schedule.
 - (2) The processing fee shall be paid to the Economic Development Board.
